## NEW RECOMMENDATIONS

*Stocks added to our Recommended List.*

The past two weeks of excitement and concern out of Greece and China appears to have stabilized—for now. We can hardly complain. Despite a miserable first week of July, our Recommended List still managed to lose a mere half percent over the past two weeks. That was much better than the 2.2% loss for the Russell 2000 Index and the 1.2% loss for the S&P 500.

Still, despite intending to buy the turmoil, last week, we demurred. When we looked at what had happened to our present stocks in the first week of July, we thought we already had a perfectly good portfolio to take advantage of the pullback with.

That turned out to be correct, but keeping our status quo was made easier by the slow filing period we're in right now for insider trades. With trading windows closed to most insiders until their firm's June quarter earnings are released, execs were limited in their ability to signal value in any suddenly cheaper shares even if they wanted to.

But back to macro factors. As far as we're concerned, Greece and China remain triggers for market weakness over the next quarter. It's great that Greece appears to have a path to stay in the Euro, but that country's ability to actually implement any reforms it signs onto is highly suspect.

And thought China's stock market appears to have found some support, the affect of the recent gyrations of that bourse on the psyche of the average Chinese investor can't be constructive. Either Chinese investors will act more conservative and skittish. Or, we think at least as likely, Chinese investors will continue to create bubbles and pullbacks in their home market as they understandably game the system under the belief that their central government will step in when the pullback becomes too painful.

So instead of buying into a stock that appeared to pull back and rebound on the recent Greek/China concerns and band aid solutions, we're adding one this issue that seems oblivious to the recent turmoil: Monster Beverage.

### Monster Beverage (MNST) @ \$139.39

All the news may be out about the strategic agreement between Monster Beverage and global drinks monolith, Coca-Cola (KO). But we're still buying in as shares of Monster try once again to punch through their old highs hit last February.

Monster Beverage markets and distributes

energy drinks under its "Monster" brand name, as well as other in-house labels. As a result of the new partnership, Coca-Cola transferred ownership of its energy brands to Monster as well. In kind, Monster transferred ownership of its sodas, teas, and juices to Coca-Cola.

Besides a \$2.15 billion cash infusion into Monster as part of the deal, Coca-Cola has also become Monster's preferred global distribution partner, with new international distribution commitments already in place and every incentive for Coca-Cola to pull out the stops on Monster's behalf. That incentive is Coca-Cola's new 16.7% stake in Monster.

The Form 3 registering Coca-Cola's 34 million plus shares of MNST got our attention when it reached our database back on June 22nd. A week after, "opting in" transactions by the two head honchos of Monster combined to put MNST's insider profile past the threshold of significance, and qualify for our attention.

By that time, obviously, all the information regarding Monster's transformative transaction with Coca-Cola was known. Intentions for the just-completed strategic and financial transactions were first announced a year ago, and sell side analysts have already upped the stock to a Buy in most cases. The financial press ranging from *Investor's Business Daily* to Cramer have also concurred with the bullish prospects the partnership holds for MNST.

But we're still hopping on this bandwagon under the belief that the expected benefits of the partnership for Monster will indeed play out, and that they aren't priced into the shares yet despite the very high multiple on MNST. The big surge in MNST in February, for instance, occurred after Monster posted better-than-expected Q4 results that showed a 12% year-over-year top line increase combined with better gross margins, and expenses that were lower as a percentage of sales. Those positive trends continued into Q1, but were overshadowed by \$206 million in one-time operating expenses related to Monster's transition to Coca-Cola from existing distributors. The expense has seemed to weigh on the shares since May, reserving a decent entry point to MNST for us now.

With Monster entering their new Coca-Cola partnership with fundamental metrics already moving in the right direction, we expect MNST's technical uptrend to continue later this year, if not sooner—and despite valuation objections.

## COMPANY UPDATES

*Updated research on past recommendations.*

### **DepoMed (DEPO)**

#### **Keeping Buy Rating.**

**Recommended: 5/18/15 @ \$20.22**

It's tough to shake a stick at a 50% gain in just two months. But we've decided not to sell into the recent buyout-related surge in DepoMed's shares.

DepoMed is a specialty pharmaceutical company that acquires and develops products for pain and other central nervous system conditions. The company's main revenue drivers in Q1 included Gralise, a once-daily product for the management of postherpetic neuralgia; Zipsor liquid filled capsule, a non-steroidal anti-inflammatory drug for the treatment of mild to moderate acute pain in adults; CAMBIA, a non-steroidal anti-inflammatory drug indicated for acute treatment of migraine attacks in adults, and; Lazanda nasal spray used to manage breakthrough pain in adults.

But DepoMed recently closed a transformative acquisition of the U.S. rights for Nucynta from Janssen Pharmaceuticals. Nucynta is indicated for the management of moderate to severe acute pain in adults, and is the only Schedule II new chemical entity opioid approved in the U.S. in the last 30 years. This new flagship product will represent the bulk of sales for DepoMed going forward.

But it's going to take several quarters for DepoMed to beef up sales of Nucynta to the levels expected. Recall also that we bought DEPO's pullback in May after management raised its expense guidance. Both these factors had us leaning towards taking profits last week after Horizon Pharma (HZNP) made a hostile bid for DepoMed.

But it turns out that Horizon only went public with its bid after being turned down by DepoMed's board back in May with a similar offer. And with DEPO now trading over \$1 above Horizon's proposed offer of around \$29.25, it seems the market senses a higher bid may be at hand. Seeing how DepMed's board just implemented a "poison pill" plan that basically kills Horizon's present offer, any other DEPO investors like us who are letting their greed surpass their fear had better hope so.

If not, DEPO will no-doubt give back a good portion the sudden takeover premium it just gained. But theoretical discus-

sions about how much a company like DepoMed is worth just got a little more concrete. And we believe the Nucynta franchise the company has just ingested has enough promise to prove DepoMed's board correct in the longer-term to have rejected Horizon's present offer.

Reasonable minds can differ—and we could change our minds ourselves if the news flow dictates. But as of now we're keeping DEPO rated Buy.

### **Omnova Solutions (OMN)**

#### **Taking Profits.**

**Recommended: 10/15/14 @ \$5.51**

**Previously Updated: 2/16/15**

**7/10/15 Price: \$7.24**

Since we last updated shares of Omnova back on February 16th, both the company's share price and earnings estimates have drifted down. With Omnova's most recent earnings received with a yawn by investors, we're taking our 31.4% profit in OMN and moving on.

OMNOVA Solutions produces emulsion polymers, specialty chemicals, and engineered surfaces for various commercial, industrial, and residential end uses. The company reports financials in two segments: Performance Chemicals and Engineered Surfaces.

With an over 30% gain in 39 weeks, OMN is still a solid winner for us since buying in. But this position has also been a laggard this year compared to the near 11% year-to-date gain our Recommended List has posted. It may seem counter-intuitive to sell OMN as it trades at a short-term low. But this most recent low is one of a series of lower lows the stock has posted since April.

This poor near-term technical trend is unfortunately confirmed by Omnova's fundamentals. When we updated OMN in February, we expected the company's Q2 (ending May 30) to come in at 13 cents versus 9 cents the year prior. For all of 2015, we had EPS increasing 68%, to \$0.47. Instead, Q2 came in at 11 cents and fiscal 2015 expectations have ticked down to 43 cents.

Neither reduction is major, but momentum is important in fundamentals as well as technicals—and Omnova's momentum has reversed in both metrics. Fiscal 2016 average EPS estimates also weakened a few pennies, to 67 cents.

If we felt strongly that Omnova's earnings had a chance at an upside surprise,

we'd be happy to stay in this value-priced stock. We do still believe in this company's longer-term turnaround initiatives. But for at least the next several months, we have no obvious reason to expect OMN's momentum to change. Global GDP concerns (related in no small part to China's economic health) are still valid, and Omnova's exposure to the oil & gas industry remains a negative in our calculus. Finally, insiders have not bothered to buy into OMN after its Q2, despite the stock being down 16% from its April high.

With Omnova's insider signal stale, and its stock's earnings and price momentum unattractive in the near-term, we're selling OMN.

# INSIDE THE MARKET

*Our Interpretation of Insiders' Top-Down Sentiment.*

Even as concerns of the market being "toppy" have grown, we remain fully invested. We agree that concerns regarding Grexit, Chinese capital markets, and interest rates could upset our bullish outlook. But on a pure insider basis, the market is still not flashing imminent warning signs.

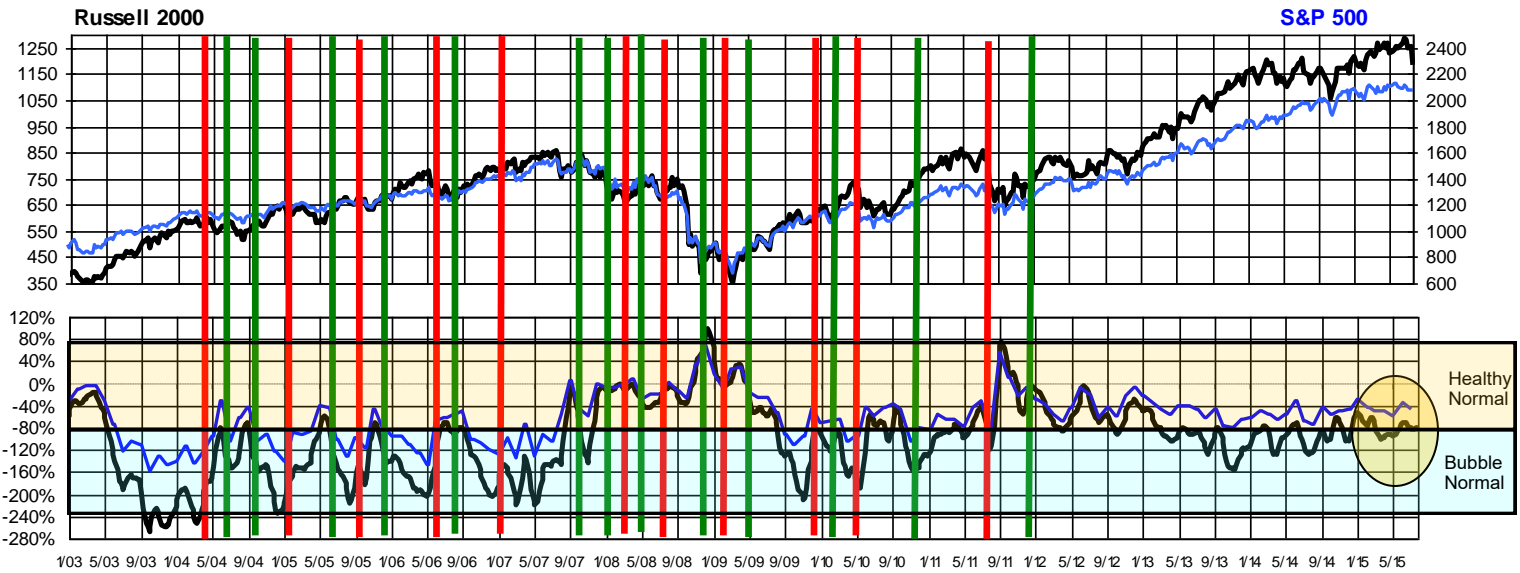
The absolute level of our Insider-Based Market Indicator (See yellow ovals in Charts below) is still not obviously bearish relative to where it has fallen during this (ongoing) financial crisis. Our Indicator is hovering at -80% (indicating there were "only" 80% more companies with open-market sales vs purchases over the past 4 weeks).

Long-time clients know we aren't perma-bulls. But we remain

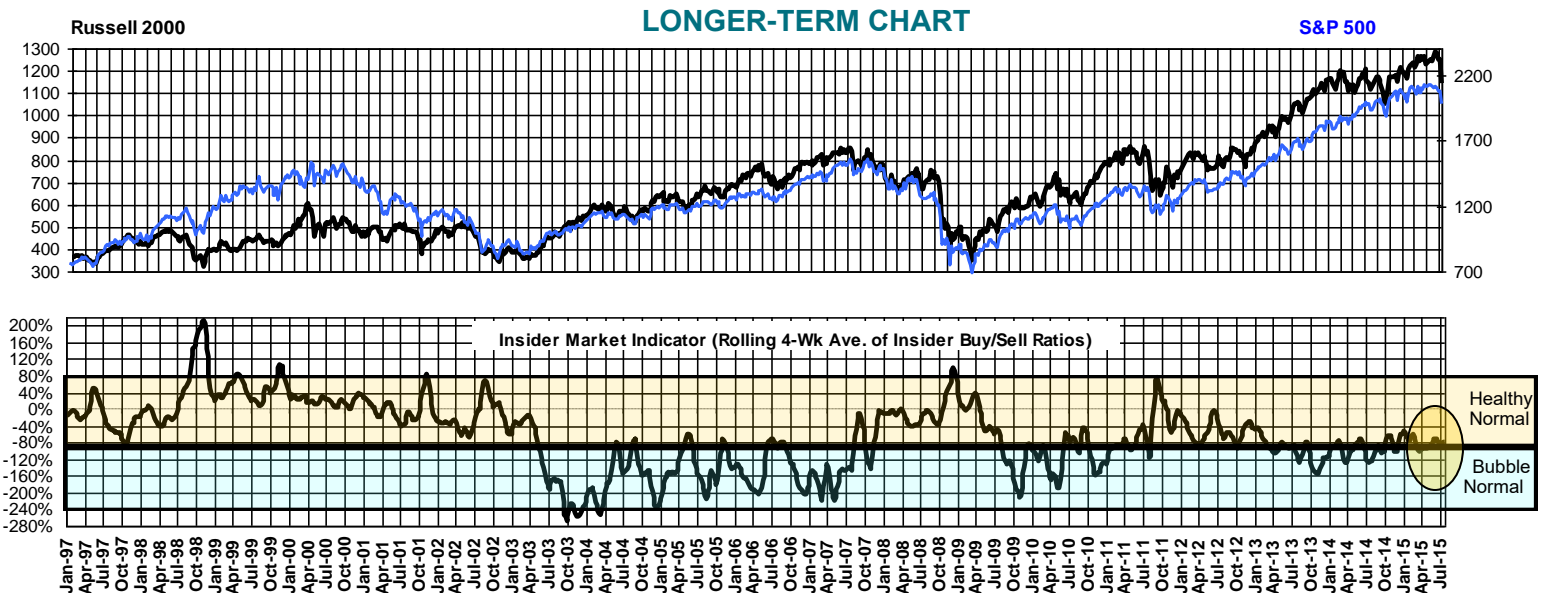
partial to the trite, but (we think) still-true arguments that U.S. equities represent a relatively attractive asset class compared to global alternatives. The U.S. economy is showing more growth and stability than other regions. We further expect money to move out of fixed income at some point in the next year as the much anticipated, but hard-to-time, end of the bull market in U.S. bonds grows nearer. Earnings at U.S. firms are relatively decent, and valuations arguably not too overstretched. There is really no need to over think why U.S. equities remain relatively attractive.

Now if we can just avoid major currency and/or political crises outside U.S. borders.
