NEW RECOMMENDATIONS

Stocks added to our Recommended List.

Rockwell Medical Tech (RMTI) @ \$4.86 (Recommended via 8/7 email alert.)

We complained in our July 15th issue about shares of Rockwell Medical spiking on us before we finished our research process. RMTI has consolidated the gains from its July surge, however, and we view the stock as offering a good entry point based on Rockwell's new product initiatives, solid base business, and newly bolstered balance sheet.

Rockwell has a solidly established business of supplying the chemicals used in dialysis (dialysates) to dialysis providers. Rockwell is one of the two major suppliers of dialysates in the U.S. market. Unfortunately, this base business is not particularly exciting from a profit point of view due largely to caps on how much Medicare and Medicaid will pay providers for these bundles of chemicals.

The dialysate business does, however, open up a valuable channel for a trusted supplier like Rockwell to distribute related products through. This is what Rockwell has been focused on for years, and its efforts finally appear to be coming to fruition this year and next.

By the end of September, Rockwell is likely to receive results from a second Phase III (CRUISE-2) study on its very promising drug called SFP. Positive results from a first Phase III trial of SFP (CRUISE-1) were what caused Rockwell's shares to surge in July. Similarly positive results in this second study will allow the company to file an NDA that could put SFP on the market by the end of 2014.

SFP stands for "Soluble Ferric Pyrophosphate", and it has already been proven to be both safe and efficacious. Annabel Samimy at Stifel Nicolaus also agrees that "it could be very disruptive therapy".

In short, SFP replaces the need for iron to be intravenously delivered into dialysis patients by acting as a replacement for it that can be delivered via the dialysate itself. SFP has both clinical benefits to patients, and economic benefits to dialysis providers by reducing the need for other (costlier) drugs now used in the dialysis process.

SFP is expected to address an estimated \$400 to \$600 million market, and could make the use of IV iron obsolete for most dialysis patients. After new financing earlier this year,

Rockwell's present \$1 plus in cash per share should be enough to pay for the company's still high R&D expenses until SFP can reach the market.

SFP would be enough of a prospect to make us interested in RMTI at its present price, but Rockwell has yet another, more timey new drug prospect to justify a punt on its shares. Rockwell looks likely to get its generic vitamin D product (Calcitriol) to market by the end of this year. All that is left in the process is to receive FDA manufacturing approval after Rockwell moved the manufacturing site.

Calcitriol is expected to compete in a \$350 million market, and Rockwell's founder and chairman, Robert Chioini, believes his firm can garner at least \$50 million in revenues from upselling a percentage of existing customers.

If and when SFP and Calcitriol do begin adding to Rockwell's top line, the sales will represent new product lines with drastically higher gross margins than its existing dialysates business. And as sales of these long incubated new products rise, the need for Rockwell's massive R&D expenditures should lessen.

While the imminent CRUISE-2 results could yet surprise on the downside, and the FDA owes no firm manufacturing or NDA approval, the odds of clinical events being favorable to Rockwell appear good. Insider are certainly betting on good news. Execs have been net accumulators of RMTI since June of 2012, and the slug of "opting in" transactions by three insiders in June was particularly hard to ignore. That troika increased their holdings notably by exercising incentive options, and selling only some or none of them. Normally, insiders flip all of their options for a risk-free profit. When they don't, it is bullish behavior.

We would be remiss not to acknowledge the large and increasing short position in Rockwell's stock for the risk factor it is. It seems that organized short sellers have chosen RMTI as a target for reasons that are not exactly clear. They became more active just before CRUISE-1 phase III results were released. It was not because they were betting they would be negative. Instead, they expected positive test results to necessitate a dilutive equity raise by

Rockwell. It is well trod strategy for investors to short a stock before an equity raise, with the intent to cover after getting a piece of the lower-priced offering. The short sellers, however, failed to get a piece of Rockwell's recent offering. Instead of admitting defeat, they appear to be increasing their activity.

We've been students of the market for too long to blithely suggest that RMTI is a candidate for a short-covering surge. Shorts have their ways, and the increased volume of trading in RMTI sug-

gests that some naked shorting is being undertaken.

But with Rockwell now fully funded, clinical results leaning positive, and more involvement on the long side by institutions after Rockwell's recent increase in both share count and trading volume—shorts appear to have a losing hand.

In any case, we're more focused on fundamentals, and believe they make RMTI a solid Buy. The next stock-moving event for RMTI should be CRUISE-2 results, which are just weeks away.

COMPANY UPDATES

Updated research on past recommendations.

Fuel Systems (FSYS) Reiterating Buy.

This volatile turnaround play is on the upswing again. With quarterly financial continuing to beat (understandably) low expectations, we are maintaining our Buy rating on this so-far winning value play.

Fuel Systems Solutions makes alternative fuel components and systems for use in transportation and industrial applications. Fuel Systems' components and systems control the pressure and flow of gaseous alternative fuels, such as propane and natural gas, used in internal combustion engines.

The story remains the same at Fuel Systems. Quarterly results continue to be lower year-over-year, but are beating expectations. Recently released Q2 EPS of 13 cents may seem disappointing compared to the 36 cents earned last year, but the number was well above expectations for just 9 cents. Investors also appeared satisfied with revenues, which rose a mere 1.8%, to \$111 million, during this period of slower growth in the likes of Europe.

Management continues to be focused on making operational improvements to

improve efficiencies. This is a necessity given Fuel Systems' still-shrinking gross margin due to rising competition.

With several recently slow geographical areas of sales showing more firmness, and the U.S. and Asian markets looking relatively more promising, Fuel Systems reaffirmed its guidance for 2013 revenue growth of about 5%, to around \$410 million, 2013 gross margin of 21% to 23%, and an operating margin between 2% and 4%.

None of which will excite any growth investors reading this update. But it's all about expectations, and it's tough not to be impressed with the gap-up in price FSYS managed in the wake of its seemingly mundane (at best) Q2 results. Technically, FSYS is again looking very bullish. The stock already appeared in a nascent uptrend before Q2 was announced last week. The subsequent surge was on very heavy volume.

Forget about PE multiples as a gauge for FSYS. As we've written previously, this stock has always looked expensive on that metric. Value has been the safety net for investors in Fuel Systems, with its strong, cash-rich balance sheet and low price/sales valuation that has only just reached 1.

Other aspects of value are seen in Fuel System's strong brand loyalty and

technology leadership. This is a company with units that have been around for decades, and a firm with relationships with most of the big players in the global automotive world.

Fuel Systems continues to be considered a buyout candidate, but we are more interested in the company making good on analysts' expectations of a return to growth in 2014. As of now, the sell side believes revenues will increase by 9% next year. EPS expectations were also increased for this year and next after Q2, to 30 cents in 2013 and 61 cents in 2014.

This growth is projected without any expectations of a legislative tailwind in the U.S. to make a shift to domestically produce natural gas more economically attractive. We've given up on such commonsense from our elected officials. Fortunately for Fuel Systems, the market is moving (albeit slowly) in the direction of more natural gas vehicles without incentives.

The insider buying by investor Kevin Douglas that originally prompted us to look into Fuel Systems was last seen five months ago. Minor insider selling into FSYS' recent strength is unremarkable, and not a concern. We still view the insider profile of Fuel Systems as leaning bullish, and FSYS as a Buy for investors comfortable with a turnaround play.

INSIDE THE MARKET

Our Interpretation of Insiders' Top-Down Sentiment.


The rolling 4-week average of our insider buy/sell ratios (eg. our Insider Market Indicator) has been in a modestly declining range since the beginning of this year (see Charts below). Our Indicator usually moves in a mirror image to how the indices are trading, so the fact that its trend is only modestly downward—instead of on a steep decline—shows that insiders are buying more and/or selling less (depending on the week) than during the stock rallies leading into the financial crisis, and since March 2009.


Insiders' relative bullishness on stocks now versus during rallies over the past several years seems a logical response to the question of "where the heck else are you going to put your money?". There is

also still plenty of cash on the sidelines, with more likely to build up as bond-fund redemptions pick up over he next year. Furthermore, taking into account the relatively positive GDP growth expectations in the U.S. versus Europe and China, and the attraction of U.S. equities versus other asset classes seems obvious to us.

Granted, our Indicator has now fallen below the range that was considered normal before all the bubbles started inflating in 2003 (See Longer-Term Chart below). U.S. equities also seem overdue for at least a consolidation of their recent gains. But the fundamental case for U.S. equities still remains convincing. And if there is a pullback, it will likely prove to be another buying opportunity.
